VIRGINIA NATIONAL BANKSHARES CORPORATION ANNOUNCES CASH DIVIDEND

Charlottesville, VA –Virginia National Bankshares Corporation (the “Company”) (OTCQX: VABK) announced today that on September 23, 2020, its Board of Directors declared a quarterly cash dividend of \$0.30 per share to be paid on October 21, 2020 to shareholders of record as of October 7, 2020. The quarterly cash dividend represents an annual yield to shareholders of approximately 5.05% based on the closing price of the Company’s common stock on September 24, 2020.

Virginia National Bankshares Corporation, headquartered in Charlottesville, Virginia, is the bank holding company for Virginia National Bank (the “Bank”). The Bank offers investment advisory services under the name of Sturman Wealth Advisors.
